## RULES AND REGULATIONS

1. The ACRA strongly recommends that the seven standard events be offered (bareback riding, saddle bronc riding, bull riding, tie down roping, steer wrestling, team roping and cowgirls barrel racing). Breakaway Roping and Steer Roping events are also sanctioned by the ACRA.
2. The National Anthem will be played and the American Flag presented at each performance.
3. The committee and stock contractor agree to comply with and are bound by all rules in the current ACRA rule book.
4. The ACRA assumes no responsibility or liability to any person, property or stock of any owner, contestant or spectator.
5. Committee and contractor agree to release and hold harmless the ACRA, its employees, directors, officers and representatives from any and all claims, damages, suit cost, expenses and loss arising out of injury or death to any person or damages to the facilities used for the production of the rodeo.
6. Rodeos sanctioned by the ACRA will not be subject to a sanction fee from the stock contractor or rodeo committee; however, seven percent (7%) of the total added money and prize money shall be deducted by the rodeo secretary for ACRA sanctioned rodeos and eight percent (8%) at co-approved rodeos, before contestants are paid, and received at the ACRA office within three (3) days after completion of rodeo along with complete rodeo results.
7. The ACRA will approve rodeos as third sanction provided stock contractor or committee pay sanction fee and finals fund to ACRA. 3<sup>rd</sup> approvals will not count toward stock contractors' finals qualification.
